Description of the Service

This service is a standard (PSTN) phone service that can be used to make and receive calls.

Minimum Term

This plan has a 24 month minimum term.

What's Included and Excluded?

The following calls are included at no additional charge:

- Local calls
- National calls

Additional charges apply for calls not included in your plan. The main charges are:

• Calls to 13/1300 numbers: 55c per call

Charges

Your minimum monthly charge for line rental is \$127.00.

The minimum amount you'll pay over the 24 month term for line rental is \$3,048.00

Early Termination

If you cancel a service or transfer a service away prior to the end of your contract term you will incur an early termination charge of \$320.00 per service.

Calls to International Numbers

Calls to Key Telecom's top 10 international destinations are charged at 20c per 30 seconds with a first minute minimum charge of 30c.

Different rates apply to call other international numbers. All international calls are charged in 30 second increments. For all international call rates, please contact us on 1300 174 637.

Connection Charges

A connection fee may apply where there is no active line present:

- Without a technician visit \$92.57
- With a technician visit \$253.75
- New telephone line installation \$467.77 with a technician visit and cabling work done up to the MDF.

Connection Timeframes

Once we've accepted your application, we'll try to connect your phone service on the date you ask for, but this might not always be possible. If there has been a previous working phone service at your property and we can reconnect it without having to visit your property, the local telephone exchange or anywhere in between, then we aim to connect the service within two working days of your request. If this isn't possible, then we aim to connect your service within five to 15 working days, depending on your location.

Billing

We will bill you in advance for the minimum monthly charge and features and in arrears for calls. Your first bill will include charges for part of the month from when you took up your plan until the end of that billing cycle, as well as the minimum monthly charge in advance for the next billing cycle.
